Historical Background

Due to ongoing and ever rising tensions nationwide between communities and municipal public safety departments, many cities have sought to create commissions to assist with addressing these tensions and improving community relations. This done in an effort to take a holistic and equitable approach to public safety, with the goal of creating a safe, dignified and human experience for all.

On May 20, 2021, the Seaside City Council passed and adopted Ordinance NO. 2003 establishing the Community Advisory Safety Commission to fulfill the city's duty to ensure the safety and well-being of its residents and visitors. (See link to ordinance)

Fiscal Year Work Plan

It serves as a roadmap for effective partnership between the Seaside Police Department and the community and may be updated by the CSAC as needed.
