RECOMMENDATION

Adopt a resolution authorizing the City Finance Director to adjust the fiscal year 2023-2024 budget in an amount of \$59,000 for lobbyist services.

BACKGROUND

On September 21, 2023, the City of Seaside City Council authorized the City Manager to execute a contract with JEA & Associates for Lobbyist Services. One component of the agenda item was erroneously omitted. Tonight's agenda item is simply a housekeeping item requesting authorization for the City Finance Director to adjust the Adopted Fiscal Year 2023-2024 to the amount necessary to fulfill the City's financial obligations agreed to in the JEA & Associates agreement.

FISCAL IMPACT

The fiscal year 2023-2024 budget included a line item for lobbyist services in the amount of \$25,000.00 (account # 100-1010-1043). The contract with JEA & Associates was for an amount not to exceed \$84,000. Therefore, an additional \$59,000.00 must be appropriated to fulfill the contract. The proposed funding source is the general fund.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEASIDE

ADOPT A RESOLUTION AUTHORIZING THE CITY FINANCE DIRECTOR TO ADJUST THE FISCAL YEAR 2023-2024 BUDGET IN AN AMOUNT OF \$59,000 FOR LOBBYIST SERVICES

WHEREAS, on June 15, 2023, the City Council of the City of Seaside adopted an annual operating budget for fiscal year 2023-2024; and

WHEREAS, the adopted fiscal year 2023-2024 operating budget included a line item for lobbyist services in the amount of \$25,000.00 ; and

WHEREAS, on September 21, 2023, the City Council of the City of Seaside authorized the City Manager to execute a contract with JEA & Associates for lobbyist services in an amount not to exceed \$84,000.00; and

WHEREAS, the fiscal year 2023-2024 appropriations for lobbyist services is insufficient to meet the obligations of the contract with JEA & Associates.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Seaside does hereby authorize the City Finance Director to adjust the fiscal year 2023-2024 budget by increasing the appropriation to account number 100-1010-1043 for lobbyist services in the amount of \$59,000.00;
