**A. RECEIVE SOLUTION RECOMMENDATIONS FROM COMMUNITY
REGARDING FIREWORKS**

The public comment received can be summarized as follows:

- Charge per instance. Example, \$1,000 per instance. 3 illegal fireworks set off, the offender will be charged a total of \$3,000.

- Shorten the time that safe and sane fireworks may be used. Currently, 6/28 - 7/5.
- Place a curfew when safe and sane fireworks may be used. Everything, illegal and legal, will be ticketed after that.
- Put safe and sane sales on the 2024 ballot.
- Offer a community fireworks program or show.
- Change the fines issued on a sliding scale, based on the time of year.
- Ban all sales of safe and sane fireworks.
- CSAC should help non-profit organizations find other solutions for funding their programs instead of depending on the proceeds from fireworks sales.
- Designated area for safe & sane fireworks within the city.
