USE PERMIT UP-23-09; ARCHITECTURAL REVIEW AR-23-18; AND MINOR USE PERMIT MUP-23-05: KANNAIHA NAIDU, PROPERTY OWNER, AND LANCE HOLT, APPLICANT, REQUEST USE PERMIT APPROVAL FOR A PROPOSED EXTERIOR STAIRWAY LEADING TO A SECOND STORY; AN ARCHITECTURAL REVIEW APPROVAL FOR A SECOND STORY ADDITION AND DECK; AND A MINOR USE PERMIT TO OBSERVE THE EXISTING NONCONFORMING EAST SIDE SETBACK OF 4'-5" FOR A SECOND STORY ADDITION TO AN EXISTING SINGLE FAMILY RESIDENCE AT 722 HAMILTON AVENUE (APN: 011-333-010) IN THE SINGLE FAMILY RESIDENTIAL (RS-12) ZONING DISTRICT.
