- A. **Board of Architectural Review Application No. BAR-15-10. Terry Ream, applicant and property owner, requests design approval for a Board of Architectural Review application to convert an existing 165 square foot second story deck into an enclosed sitting room at an existing single-family residence. The subject property is located at 1506 Ord Grove Avenue in the Single-Family Residential (RS-8) Zoning District (APN: 011-082-008). This project is exempt from the California Environmental Quality Act pursuant to Class 1, Section 15301.e.1: Existing Facilities.**

PURPOSE: In accordance with Section 17.62.030.B.2 of the Seaside Municipal Code, Board of Architectural Review approval is required for the construction of all new second-story elements including decks. The applicant is proposing to convert a second story deck into an enclosed sitting room.

Staff recommends approval of the proposed second story addition subject to the conditions of approval provided as Attachment 1, Conditions of Approval.
